YOUR FINANCIAL VERIFICATION MUST BE ACCOMPANIED BY A BANK STATEMENT, A SPONSOR'S LETTER OF GUARANTEE, OR A LETTER CONFIRMING A SCHOLARSHIP OR LOAN. An acceptable financial document must have been issued no longer than nine months before you intend to enroll. Copies of these documents should be kept to present to the U.S. Consulate at the visa interview and to the U. S. Immigration officers at your port of entry. Costs: See the enclosed list of estimated expenses for your first year of study.

Work: You should not consider employment as a means of support for yourself or your family. International students can work on campus, but jobs are hard to find and pay minimum wage. Regarding work off campus, U.S. Immigration regulations prohibit international students from working off campus during their first year in the U.S. and make it extremely difficult to obtain permission to work in succeeding years as well. The spouse and children of a student on an F-1 visa are not permitted to work under any circumstances.
